SCHOOL DISTRICT NETWORKS AND INTERNET ACCESS FOR STAFF

The School Board recognizes that technological resources can enhance teacher performance by offering effective tools to assist in providing a quality instructional program, facilitating communications with parents/guardians, teachers, and the community, supporting District and school operations, and improving access to and exchange of information. The Board expects all staff to learn to use the available technological resources that will assist them in the performance of their education. As needed, staff will receive training, lessons, and instruction in the appropriate use of these resources.

Staff will be responsible for the appropriate use of technology and will use the District's technological resources primarily for the purpose of supporting teaching and learning consistent with the mission of the Goffstown School District. Staff are hereby notified that there is no expectation of privacy on District computers, computer files, emails, internet usage logs and other electronic data.

The Superintendent in consultation with the District Information Security Officer (ISO) will ensure that all District computers/devices with Internet access have a technology protection measure that prevents access to visual depictions that are obscene or pornographic and that the operation of such measures is enforced. The Superintendent or their designee may disable the technology protection measure during use by an adult to enable access for bona fide research, educational or other lawful purpose.

The Superintendent will establish administrative regulations and an Acceptable Use Agreement that outlines staff obligations and responsibilities related to the use of District technology. The Superintendent may also establish guidelines and limits on the use of technological resources. Inappropriate use may result in a cancellation of the staff member's user privileges, disciplinary action and/or legal action in accordance with law, Board Policy, and Administrative Regulations.

The Superintendent or their designee will provide copies of related Policies, Regulations and Guidelines to all staff. Staff will be required to acknowledge in writing or electronic signature as applicable, that they have read and understood the District's Acceptable Use Agreement.
